2010 Spring Tour – Bridging the Tuscarawas Gap
April 30, May 1 & 2, 2010**

See the artifact packed Tuscarawas County portions of the Ohio & Erie Canal. Includes the Great Tuscarawas Aqueduct and the Fort Laurens trailhead. Ride in golf carts to see the new 1-77 foot/bicycle/horse bridge. See the 10 mile level sluice gate, locks 7, 8, 9 and 10, culvert, feeder gate, fish hatchery and Iron Truss Bridge. Join in a docent led walking tour of Zoar and its historic buildings, mill sites, guardlock and dam. Lunch in the Zoar Schoolhouse. Bus tour of New Philadelphia's slackwater dam abutment, Blake's Mills lock 13, Canal House Tavern, Upper Trenton lock 15, and non-rebuilt lock 19.
