On your Own:

Visit nearby Haubstadt Antique Mall on U.S. 41

Visit Dewig Meats (1916), world's largest meat market 12,000 ft., 100 Maple St. in Haubstadt  
There will be a refrigerator in your hotel room. Bring a cooler. Purchase German bologna, bratwurst, liver sausage, etc., cheeses, all cuts of beef, pork, chicken, turkey, etc., wine, condiments, etc. Many meats may be purchased frozen as well. Not open on Sunday.

Friday night: Dinner on your own at nearby restaurants. We suggest:

Log Inn: One mile east of US 41 The Log Inn was built in 1825 as a Noon Day Stage Coach Stop and Trading Post. It is recognized as Indiana's oldest restaurant. Abe Lincoln ate there in 1844. Known for family style fried chicken or ham meals. **Suggest making a reservation.**

Stoll's County Inn: US 41 next to State police post, Amish Buffet freshly cooked with large variety of dishes

Saturday morning tour: Car caravan with walkie-talkie's provided by CSI

We will carpool and see sites so remote that coaches are too heavy for the bridges and will not run on gravel roads. There will be lots of canal prism to follow with stops at long watered sections. We ask each person in the carpool to give \$5 to the driver towards his fuel cost the day of the tour. Pass through canal towns of Port Gibson, Fransisco, Dongola, Glezen, Hosmer & Petersburg. See location of the Deep Cut.

Saturday lunch: Schnitzelbank in Jasper, Indiana with live accordionist, sing-a-long program and history of Jasper.

CSI annual meeting at lunch

Saturday afternoon: Tour Jasper County Mill to see corn ground and tour the Dubois County Museum with docents at exhibits, located in the huge old Kimball Organ factory

Saturday dinner: Nesbit Inn also known as Nesbit Station, Built around 1911 for a railroad inn and tavern, this remote restaurant still has very old murals in one section. Known for its beer served in iced mugs, barbeque, cheese, and pies.

Sunday: We suggest touring sites in Evansville: the LST, Willard Library with great genealogy collection open 1-5, the Evansville Museum or Zoo
